On the 3rd of November 1993, at approximately 12.15hours, I monitored 105.1Mhz at the Albert Dock, Liverpool. I heard a broadcaster say that he had just switched on the transmitter and that "ZEE 100" would start transmitting their programmes from 15.00 hours.

I took a new audio tape from its wrapping and inserted it into my tape recorder. Using a microphone which was plugged into the unit I then identified myself and made a note of the time as being 12.35hours, the location, and also the frequency I was monitoring. I then proceeded to record the station on 105.1Mhz which was by this time playing music. I allowed the tape to run its full course and the recording ceased at approximately 13.20hours.

I contacted my colleague Malcolm Cameron Foulds, and arranged to meet him in the Birkenhead area so that further proof could be obtained regarding the stations location.

At 15.00hours I together with Malcolm Cameron Foulds, Radio Investigation Officer, monitored 105.1Mhz in the Birkenhead area, and heard the radio station "ZEE 100".
